### **Executive Summary**

# 1.1 Analysis of ethics issues per WP

## 1.1.1 WP1

The meeting was recorded in the Microsoft Teams tool of the host partner, TREE, and only available to participants for 7 weeks. The recording was deleted from the system on October 28<sup>th</sup>.
